'Can CRS (Colo-Rectal Surgery) be made Ambulatory?'

While researching for this lecture, I came across a couple of interesting statements, that I though I should share with you.

A Google search brought up:

- Prepared by the Clinical Practice Guidelines
 Committee of the American Society of Colon and Rectal surgeons:
- ...it is estimated that 90% of anorectal cases are suit able for ambulatory surgery.5,7,8 these procedures are considered low-risk surgery, and patients can expect to be discharged home safely and comfortably the same day.9,10 however, the surgeon must consider the expectations of the individual patient, comfort level, and potentially complicating comorbidities or other extenuating circumstances before deciding on an ambulatory setting.6,1

And, a search using AI:

Yes, colorectal surgery can be performed on an ambulatory basis, meaning patients can undergo surgery and be discharged on the same day without the need for an overnight hospital stay. This approach is increasingly common for various anorectal procedures, including those for conditions like hemorrhoids, fissures, abscesses, and fistulas¹². Ambulatory colorectal surgery offers several benefits:

Reduced Costs: It can significantly lower hospital charges by 25% to 50%¹.

Patient Satisfaction: High levels of patient satisfaction have been reported, with rates around 92.4%¹.

Safety and Efficacy: Studies have shown that these procedures are safe and effective, with low perioperative morbidity and mortality¹.

However, the suitability of ambulatory surgery depends on various factors, including the patient's overall health, the complexity of the surgery, and the availability of appropriate postoperative care²³.

So, importance of basic Protocols of Day Surgery cannot be over emphasized. Internationally and nationally, suitable Protocols are in place for a safe and successful Day Surgery procedure.

The Indian Association of Day Surgery recommends:

- 1) Patient Selection Protocols, including ASA Criteria's.
- 2) Patient Preparation, including Counseling.
- 3) Anaesthesia Protocols.
- 4) Discharge Protocol.
- 5) Follow-up recommendations.

Depending on the type of Surgery, anaesthesia is decided.

Insurance:

Cashless or Reimbursement for a Day Care Surgery is acceptable by all Medical Insurance companies in India.

Each Policy has a list of Day Surgeries, which **Do Not** require 24 hrs admission. I have tried to collect links to these insurance companies for your information.

It is the Insurance Agents, who, most of the time, insist on Over-Night admission. Not the Insurance Company, nor the TPA!
